The role of the emergency manager is quickly becoming professionalized. We are moving from a workforce of committed individuals who are assigned to the emergency management role as part of their regular public safety duties toward those individuals who study emergency management

in degree programs to serve their communities. This movement is critical to our abilities to address the threats and hazards of today and tomorrow.

We are seeing more complex disasters that engage more than just flooded out neighborhoods or the loss of a dozen structures in the wildland interface. The complications of the response are just the tip of the iceberg of the overall recovery of the community. Disasters today require tomorrow's emergency managers to understand all facets of the disaster cycle and be able to provide this expertise to our community's elected and appointed leadership.

Chris will speak about the technical evolution of the comprehensive emergency manager and the role of this professional as a part of the public safety team in a community that works together to help people, before during and after disasters. In addition, he will address the benefits of these members of our public safety teams and help to articulate there is a lot to do in this space given the intensity and frequency of disaster, the politics and economics of disaster as well as the role of government and voluntary organizations active in disaster.

Course Description:

This 2-day course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire and EMS environment. The course includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry based dialogue; ethics; authority; power; decision-making; and active engagement through development of a personal plan.

Continuing Education Units: 1.4

Maximum # of Students: 20

Selection criteria

The primary target audience for this course are those individuals who are at the first line level of supervision. For purposes of student selection first line level is considered to be those at the Company Officer or Unit (fire prevention, fire education, communications, EMS, etc.) Supervisor level.

More specifically primary selection criteria are as follows:

- *First line supervisors in fire and emergency medical services organizations.*
- *Fire and emergency medical services personnel due for promotion/appointment to a first line supervisory position within 18 months.*
- *Fire and emergency medical services personnel who are regularly assigned acting supervisory positions.*
- *Fire and EMS personnel currently enrolled in the National Fire Academy Managing Officer Program will be provided priority selection.*

The secondary target audiences are fire and EMS personnel at the first line management level (Chief Officer or above). Students at this level may be given consideration on a space available basis.

–Participants are required to provide their own structural firefighting ensembles (garments, helmets, hoods, gloves, and footwear) that comply with NFPA 1971 and NFPA 1500.

–Participants are also required to provide their own respiratory protection (SCBA – Self Contained Breathing Apparatus) that complies with NFPA 1852 and 29 CFR 1910.134.

Each participant must complete a Nevada State Fire Marshal Division Live Burn Accountability form as part of the registration for FireShowsWest. This form must be signed by the Chief of their agency or the Chief's designee. A contact phone number for your agency is required.

The training will utilize two types of mobile training props that include an LP-Gas Fire Simulation Prop, and a Car Fire Trainer Prop.

–The Mobile LP-Gas Simulation Prop is constructed utilizing a 320-gallon container and fueled by liquid propane. It has a simulated relief valve that can produce flame heights of approximately 35 ft. There are two valves on the container that the participants must close.

–The Kidde Car Fire Trainer Prop realistically replicates a car fire in a safe environment. It has multiple burn zones and is able to produce scenarios such as: engine fire, forward passenger area fire, rear passenger area fire, fuel spill fire. It has a hinged hood, trunk, and passenger doors to allow access into the different compartments and the hood is pry-able which allows participants to conduct forcible entry drills.

Forcible entry with the irons is one of the cornerstone skills of our profession. The ability to put these skills into practice, modify techniques for desired outcomes in specific circumstances, and impart this knowledge for others without wasting cognitive capital is crucial. Elevating your forcible entry game to journeyman status makes us more effective on the fireground, thus more effective for the public's safety and the safety of ourselves. The H&H cadre will take your comprehension and application of one of our profession's fundamental skill sets to the next level through in-depth explanation, demonstration, and assist application of the HOW and WHY behind the irons. By the end of this course, attendees will possess an in-depth and intimate knowledge of the how and why behind the irons. Attendees will through lecture, demonstration, and hands-on participation, be able to confidently and competently walk away with a journeyman level comprehension.

This hands-on training session will require liability releases to be signed by September 16, 2022.
